Owner privileges (In the period when the owner is not renounced)

- Owner can change trading status.
- Owner can authorize / unauthorize addresses.
- Authorized addresses can change the maximum transaction amount.
- Authorized addresses can change maximum amount per wallet.
- Authorized addresses can change restrictWhales value.
- Authorized addresses can include in and exclude from fees.
- Authorized addresses can include in and exclude from maximum transaction limit.
- Authorized addresses can include in and exclude from dividends.
- Authorized addresses can change liquidity, reward and extra sell fees.
- Authorized addresses can change auto liquidity receiver.
- Authorized addresses can change swap back settings.
- Authorized addresses can change distribution criteria.
- Authorized addresses can change distribution GAS.

Conclusion

Smart contracts do not contain high severity issues! Smart contracts contain owner privileges. Liquidity pair contract's security is not checked due to out of scope.

Liquidity locking details are NOT provided by the team.
